LOGAN COUNTY LIVES UNITED! HERE'S WHAT YOU'VE HELPED US ACCOMPLISH THIS PAST YEAR.

United Way is the philanthropic hub of Logan County. Since 1955, generations of local residents and businesses make their charitable impact through United Way. When you give to United Way, you become a part of a long-standing solution that works to positively influence the health, education, and financial stability of every person in Logan County. More than just a fundraiser, United Way collaborates with businesses, non-profits, government, and civic organizations to address the growing needs of our community.

More than 700 volunteers committed time and talent on our Board, committees, and special events this past year. 2,524 individual and 166 local businesses gave of their treasure to lift up our 2024 Campaign. \$1,025,350 was raised as Logan County, the smallest community in Ohio to ever have a \$1 million Campaign for its local United Way, did it for the seventh straight year! 16 workplaces set all-time giving records. Traditional workplace campaigns accounted for 75 percent of our campaign revenue this year.



Ben Vollrath, President of the Logan County Chamber of Commerce, served as the 2024 United Way Campaign Chair. "Giving to United Way is more than just checking a box or doing something out of a sense of duty," Vollrath said. "These dollars make a difference!"

"It's not always in your face. But the needs are massive here. So when you give to United Way, there's a face on the other side of that dollar that is being blessed, that is being impacted. It's about the people who get the support and the help."

VOLUNTEERS ENABLE LUNCH BUDDIES TO EXPAND TO ALL COUNTY SCHOOLS



Lunch Buddies continues to be a strong United Way program and a favorite of so many of our volunteers who are involved.

We have Lunch Buddies in all our Logan County schools with 230 matches pairing adult role models and 3rd, 4th and 5th graders. Some of our volunteers have been with the same buddy for the third year in a row and will see them graduate out of the program this spring. Volunteers commit to spending one lunch period a month with their buddy.

We can't say enough about the staffs at all the elementary schools for working with us to make this possible. Thank you to the volunteers who take time each month to make their visits.

POVERTY SIMULATIONS EXPLAIN REALITY, EXTEND EMPATHY



In addition to local schools, Lutheran Community Services hosted a Think Tank Cost of Poverty Experiences last October. Simulations were conducted for members of Student United Way and Leadership Logan County to help them better understand situations that many in our community face daily.

"The simulation was very moving and very impactful to me," said one participant. "I had no idea of the depth of this and all the issues that come with it! A lot of us were trying to make light of this and treat it like a game because it would be so difficult to accept the reality of what it's actually like for people day to day. But after I left, I kept thinking about it. It really DID work. This is in fact, a call to arms. Is poverty too big, and do I feel powerless? You bet. However all of us can do something."

HELP WITH BASIC NEEDS

Did you know? The number one reason why people call United Way is for help with rent or utility assistance? We fielded over 500 calls for this type of help in 2024. With your support, we were able to help 393 individuals prevent evictions with over \$120,000 in financial support through our Housing Stability Program, which also provides budget counseling and referrals to other organizations.

More than 7,000 Logan County residents received food from United Way funded agencies that are fight food insecurity. Lutheran Community Services served nearly 60,000 meals. Second Harvest Food Bank's mobile pantry distributions throughout the county served over 4,500 unduplicated individuals. GRACE and the Neighborhood Outreach Centers feed children on weekends or over the summer, while LifeCare Alliance delivers meals-on-wheels daily to our homebound senior citizens.

Warm Clothes for Kids outfitted 400 students in Grades K-12 countywide this fall.

Dolly Parton Imagination Library sent over 22,000 books were sent to Logan County children age 0 to 5 years in 2024. Over 166,000 books have been sent over the last nine years.

INDIAN LAKE TORNADO RELIEF FUND

More than 5,000 donors gave over \$1.7 million to the Indian Lake Tornado Relief Fund. Donations poured into our community from 40 states coast-to-coast, including California, Maine, Washington, and Florida. Businesses, schools, churches, and groups around Ohio conducted special fundraisers. Several donors have written letters expressing fond memories of growing up here. One woman reminisced about meeting her husband one summer at Indian Lake.

\$1,441,378.98 was provided in direct support to 548 affected households (1,231 individuals) of the March 14 tornado. Affected families began meeting with United Way's team of case workers on Wednesday April 10. Through Friday May 31, here is the breakdown in how tornado victims are choosing to use their United Way help:

- 100 "other" expenses, such as storage, generators, food, furniture, appliances, etc. - \$69,375.93
- 277 home insurance deductibles - \$390,765.72
- 204 home repairs - \$368,944.82
- 137 rents for new or existing housing - \$195,762.22
- 89 utility bills - \$32,688.21
- 76 mortgage payments - \$82,878.14
- 68 auto insurance deductibles - \$48,600.17
- 52 car repairs - \$53,924.77
- 43 security deposits for new housing - \$65,716.42
- 43 car payments - \$38,547.72
- 35 down payments on a new car - \$71,685.05
- 29 hotel stays - \$17,537.21
- 9 student hardship fees - \$1,117.46
- 9 pet cares - \$2,520.71
- 7 prescription medications - \$1,314.43



Remaining and future funds were and continue to be turned over to the Logan County EMA's Long-Term Recovery Team, which is working to identify and fulfill unmet needs after insurance, government, and charitable support. Help is coordinated on a case-by-case basis.

STUDENT UNITED WAY

28 high school juniors and seniors completed Student United Way, our six-month leadership development program. They were exposed to the human service issues facing Logan County and allocated over \$29,000 to local teachers and agencies who are working to address them.

"Student United Way opens the eyes of the students as to what goes on in the community that many aren't aware of, and shows how much need there still is, said Mya Burrey, a senior at Benjamin Logan. "After seeing the needs, being given money to allocate toward our community allows us to be able to make an impact as well."

LOOKING AHEAD TO 2025

Our Allocations Committee approved \$880,000 in funding recommendations to support the work of 20 Funded Agencies in Logan County in 2025. Agency requests exceeded the amount available by 38%. Yet 18 of the 30 programs will receive what was requested. The complete list of 2025 Allocations is on the next page.

In February 2024, 50 community members came together at the Public Innovators Getting Started Lab to learn the Harwood Approach for creating community-led, community-driven change. The network formed three cross-sector action teams made up of community leaders—Youth, Whole Health, and Seniors.

With support from The Harwood Institute and United Way of Logan County, the teams are getting in motion by engaging

the community through conversations about their shared aspirations. Across the network, over 35 conversations have been conducted, including more than 350 attendees, with more community conversations and sharing public knowledge events to come this winter and spring.

The teams are using the public knowledge gathered to take initial actions rooted in what matters to people. Over time, these actions will unleash a chain reaction that will take root, grow, and spread throughout the community.

Ripples are starting to spread, including community-based projects like the Neighbor-to-Neighbor program, Senior Citizen focused technology training, and the Week of service for Students. The three teams remain dedicated to



Continuing Community Conversations in areas that they have identified, meeting monthly and working together, and taking the action steps that they learned and identified from the November Lab.
