LOGAN COUNTY LIVES UNITED! HERE'S WHAT YOU'VE HELPED US ACCOMPLISH THIS PAST YEAR.

United Way is the philanthropic hub of Logan County. Since 1955, generations of local residents and businesses make their charitable impact through United Way. When you give to United Way, you become a part of a long-standing solution that works to positively influence the health, education, and financial stability of every person in Logan County. More than just a fundraiser, United Way collaborates with businesses, non-profits, government, and civic organizations to address the growing needs of our community.

More than 700 volunteers committed time and talent on our Board, committees, and special events this past year. 2,524 individual and 166 local businesses gave of their treasure to lift up our 2023 Campaign. 12 workplaces set all-time giving records. Traditional workplace campaigns accounted for 75 percent of our campaign revenue this year. Others made one-time gifts. Still others sponsored events or donated in-kind product or service donations. We can't do our work without all of you!



Motivated to help alleviate hunger in our community, Brittany Saxton, Six Hundred Downtown owner and five-time World Pizza Champion, serves as our Campaign Chair. "It blows my mind," Saxton said. "It's 2023. Nobody should struggle with food. Or be worried about where it's going to come from. But it also makes me happy that we have those resources, because without them, that's a million meals not eaten."

VOLUNTEERS ENABLE LUNCH BUDDIES TO EXPAND TO ALL COUNTY SCHOOLS



This is one of our favorite **Lunch Buddies** photos of the year. The pure joy on their faces exemplifies the feelings that occur when the 600 people who participate in our monthly mid-day mentoring program get together. Lunch Buddies expanded to all Logan County schools with over 300 matches pairing adult role models and 3rd or 4th graders. Volunteers commit to spending one lunch period a month with their buddy. In August, the Bellefontaine Education Association presented Melody Couchman with their Friends of Education Award for her work coordinating this pilot program. We can say enough about the staffs at all the elementary schools for working with us to make this possible and the volunteers who take time each month to make their visits.

POVERTY SIMULATIONS EXPLAIN REALITY, EXTEND EMPATHY



More than 520 people participated in six **Think Tank Cost of Poverty Experiences** we put on this year. Simulations were conducted for teachers at Bellefontaine and Benjamin Logan School districts during professional development days to help them better understand situations their students may be going through.

"The simulation was very moving and very impactful to me," said one participant. "I had no idea of the depth of this and all the issues that come with it! A lot of us were trying to make light of this and treat it like a game because it would be so difficult to accept the reality of what it's actually like for people day to day. But after I left, I kept thinking about it. It really DID work. This is in fact, a call to arms. Is poverty too big, and do I feel powerless? You bet. However all of us can do something."

COMMUNITY CARE DAY

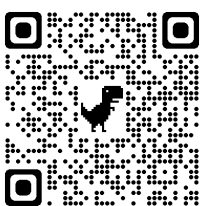

Did you know? The number one reason why people call United Way is for help with rent or utility assistance? We fielded over 800 calls for this type of help in 2023. With your support, we were able to help 197 families prevent evictions or utility shutoffs with nearly \$110,000 in financial support through our **Housing Stability Program**, which also provides budget counseling and referrals to other organizations. Our Licensed Social Worker, Ashley Spence, also met with one-on-one with 188 employees at participating workplaces through our **LIVE UNITED @ WORK Financial Wellness Program**, assisting with non-work related problems.

More than 7,000 Logan County residents received food from United Way funded agencies that are fight food insecurity. **Lutheran Community Services** moved into their new facility on West Sandusky Avenue in September and then doubled the number of meals provided in the 4th quarter from 2022, (18,000 meals). **Second Harvest Food Bank's** mobile pantry distributions throughout the county served over 4,500 unduplicated individuals. **GRACE** and the **Neighborhood Outreach Centers** feed children on weekends or over the summer, while **LifeCare Alliance** delivers meals-on-wheels daily to our homebound senior citizens.

Warm Clothes for Kids outfitted more than 430 students in Grades K-12 countywide this fall.

SUPPORT FOR MENTAL HEALTH

We awarded 11 grants in 2023 totaling more than \$46,000 to NEW programs designed to increase awareness and access to mental health support for students and adults. We're piloting a new collaborative effort, Stress Less, an art, music, and theatre therapy program taking place after-school this year at the Holland Theatre. A \$15,000 United Way grant to **LoCo Art** brings teachers from local schools and counselors from Community Health & Wellness Partners together to work with students in Grades 5-12 to develop coping skills. Another \$15,000 grant to **Journey Living Ministries** provides scholarships to participants for guided coaching to develop coping skills, resilience, and healing from past trauma and difficult life experiences.

In all, we awarded over \$106,000 to 17 partners through our **Community Impact Fund** in 2023.

STUDENT UNITED WAY

28 high school juniors and seniors completed **Student United Way**, our six-month leadership development program. They were exposed to the human service issues facing Logan County and allocated over \$29,000 to local teachers and agencies who are working to address them.

“I learned about the real, and often un-talked about needs of the community and of the less fortunate,” said Abigail Hermiller, a junior at Calvary Christian. “I learned about the number of families who are really struggling and that was eye-opening. United Way matters because it is helping the less fortunate. It is important to stay connected to the community and to help in any way possible. It is important not to be ignorant about the realities around us.”

LOOKING AHEAD TO 2024

Our **Allocations Committee** approved \$580,000 in funding recommendations to support the work of 20 Funded Agencies in Logan County in 2024. Agency requests exceeded the amount available by 29%. Yet 16 of the 26 programs will receive what was requested, with two programs receiving increased support over 2023 funding. The complete list of 2024 Allocations is on the next page.

In Fall 2023, United Way was approached with an opportunity to serve as the local partner with the **American Honda Motor Company** and the **Harwood Institute** on a new Logan County Initiative.

This initiative has three primary goals:

(1) Take action on key issues that matter to people; (2) Strengthen Logan County’s civic culture so the community can accelerate and deepen its good work; and (3) Ensure Honda’s investments create sustainable impact aligned with the shared aspirations and needs of the community. At the heart of this initiative is the belief that by working together, the people of Logan County can build a shared and hopeful path forward. Logan County is close-knit and home to great schools. Local pride runs deep. Today, the community faces a critical choice: Stay on the current path and potentially stagnate or get on a more productive path by coming together to forge a bright future.
